Rule 14	6 of the Tennis Auckland Constitution as I am not a person who:
a.	has been adjudged bankrupt who has not obtained a final order of discharge or whose order of discharge has been suspended for a term not yet expired, or is subject to a condition not yet fulfilled, or to any order under the Insolvency Act;
b.	has been convicted of any offence punishable by a term of imprisonment of two or more years unless that person has obtained a pardon or has served the sentence imposed on them;
C.	has been sentenced to imprisonment for any offence unless that person has obtained a pardon or has served the sentence imposed on them;
d.	is prohibited from being a director or promoter of or being concerned or taking part in the management of a company under the Companies Act 1955 or Companies Act 1993; or
e.	is subject to a property order (lacking in competence to manage own affairs) made under the Protection of Personal and Property Rights Act 1988.
