





# President's Report

**As President of Tennis Auckland for the season 2010/2011 it is my pleasure to submit a report on my activities and observations over the past year.**

Firstly, on a sad note, we lost our valued Life Member Rae Reynolds who was in her late 90's but still regularly attended the major events. There is a garden in her memory at the ASB Tennis Centre. And earlier, we were also very sad to lose Vivienne White, wife of Alan White Life Member. Viv was only in her mid-fifties and will well be remembered as a talented player and volunteer especially in the Player Liaison area of the Major Events.

I would like to congratulate the Board of Tennis Auckland and in particular the Chairman Alan Chester for the time and expertise all have given voluntarily during what I can only describe as one of the most difficult years in the history of the Association. In my capacity this year I have been privileged to have been invited to attend the Board meetings in an observer's capacity and have been amazed at the diversity of issues they have had to deal with. I can assure the clubs that Tennis Auckland is indeed in good hands.

It has not been an easy year for the Board especially with the associated upheaval in the redevelopment of the Stadium. But what a magnificent place we are going to have when the new facility is up and running.

To this end I would like to also thank most sincerely the staff of Tennis Auckland. For them it has indeed been a very difficult year with fewer courts to run their domestic events, and the shifting and again resitting of their office areas but they have persevered and it is indeed a tribute to them that under the difficult circumstances of the new development, the two major events were presented in such a professional manner.

To the Clubs, I have enjoyed visiting on some of your special days. It is very obvious which clubs will succeed in the future by the quality of the volunteers you have. I am most impressed. Over my 15 years as your Executive Secretary in the 80's and 90's I made a tremendous number of friends and it was great to catch up with so many throughout the year. I would like to point out however my disappointment at the attendance at Delegates meetings throughout the year with less than 50% of clubs attending. There are only four meetings a year with one being the Annual General Meeting and Clubs should make sure that they have a representative in attendance at all meetings.

And finally, good luck to Howard Lewis who will this year take over from me as President. He will have an exciting time and I know that he will be a capable person at the helm.

# Chairman's Report

## On many fronts, the 125th year of Tennis Auckland has been very challenging.

The Board is managing several major initiatives which it believes will significantly enhance the sport through improved facilities and services, and greater revenue generating opportunities. Managing the transition, and the associated costs, is requiring the full attention of the Board and staff. The challenges were complicated when our CEO of less than 18 months resigned in November 2010 and the new CEO appointed in December 2010 failed to take up the position at the last moment. It is only as of July 2011 that the position has been filled.

Despite the challenging circumstances, the International Events attracted several marquee players and created considerable public interest; the redevelopment of the ASB Tennis Centre has progressed largely to plan and budget; and we have seen Auckland players succeeding internationally.

You will note that the format of the presentation of the financial accounts is different from previous years. This is in line with current financial reporting requirements to give greater clarity of the financial information and identification of total revenues and costs, rather than revenue and costs being segmented into various categories.

The result for the year ended 30th April 2011 is a Net Loss of \$337k (2010 \$201k loss) which includes depreciation of \$198k (2010 \$223k) resulting in an operating cash loss of \$139k (2010 \$22k profit).

The principal reasons for this unsatisfactory result were as follows:

1. The continued loss on Domestic operations (i.e. not related to the International Tournaments),
2. The high operating costs of the Scarbro Tennis Centre. The major cost of the centre is the annual payment to TNZ of \$107kpa, which is in perpetuity. This payment is being renegotiated. The Board is very focused on endeavouring to improve the total Domestic financial results.
3. A \$237k reduction in Net Profit from the International events brought about by increased operational and player costs. There is an on going requirement to lift the standard of these events which will see costs increasing each year.

In addition to the Net Loss as above, there was additional capital expenditure of \$148k to enable the International events to take place while the ASB Tennis Centre was under construction.

All of the above has placed a financial strain on the position of Tennis Auckland.

I thank our sponsors who are enthusiastic about the coming year's events and for their support, which, together with the initiatives being put in place, positions Tennis Auckland to grow and develop to produce a much improved result for 2012 and beyond.

I wish to thank President Pam for her great involvement and interest during the year. She has carried out her Presidential tasks with obvious enjoyment and enthusiasm. I also thank the Board members for their time and tremendous commitment to the future development of Tennis Auckland.

We would like to thank the following Trusts for their ongoing support. Tennis Auckland could not continue to achieve its game development goals without their support.

# Major Events Chairman's Report

Over the years, we have just about experienced every possible set of circumstances. However, 2011 was the first year we have played at a work-in-progress construction site. The Next Generation Club's development programme was in full swing but with great co-operation from ARGON Construction, the area was transformed into a first class (if somewhat temporary) tournament facility. The court surfaces were all completed with newly laid Plexi-cushion (to match the Australian Open). Players, staff and the public demonstrated real willingness to make sure everything worked out smoothly. Even the weather co-operated!

During the ASB Classic play was delayed one morning for just 15 minutes as we dried off some overnight "Scotch Mist" and the following week at the Heineken Open Thursday night play was restricted to just the singles match. The players came off court with a slight drizzle falling but then came the deluge and a quick decision by the ATP Supervisor Tom Barnes and Tournament Director Richard Palmer meant that the doubles match (with no players involved in singles) could easily be played on Friday morning. Probably one of our least weather affected fortnight over the years.

The reports from both Supervisors from the WTA and ATP were very positive but both identified areas where some upgrading is required – there is always something to be done.

## ASB CLASSIC featuring KIA MOTORS Singles and Doubles

The ASB Classic is the first event on the WTA Tour and because of the proximity of the Australian Open attracts a wide range of international players. This year 27 nations were represented and notably no-one from the USA was in the main draw although there was a small group in the qualification section headed by Jill Craybas who returned for her twelfth visit.

Richard Palmer, returning as Tournament Director, continued his fine recruitment record attracting a talented and glamorous field headed by Maria Sharapova, listed as one of the richest female athletes in the world. The Russian trio of Sharapova, Kuznetsova and Safina sometimes ranked 1 or 2 in the world share 3 Grand Slams, 7 grand Slam Runner Up and 47 WTA Titles. What a line up! Our last year's Champion Yanina Wickmayer returned as promised as second seed.

We witnessed some hard fought matches – 15 matches included tie breaks and 18 singles matches extended to three sets but only one doubles match required the super tiebreak decider. Auckland is not kind to seeded players as only three seeds contested the Quarter Finals which included a young qualifier and a wild card. Two seeds made the semis. For the record a somewhat unknown Hungarian Greta Arn at 31 years old ranked 81 in the world defeated Belgian Yanina Wickmayer at 21 years old ranked 23 in the world 6-3 6-3. You never can predict the result of a tennis match. In the doubles the No. 1 seeds Kveta Peschke and Katarina Srebotnik defeated our local heroine Marina Erakovic and Sofia Arvidsson 6-3 6-1. Well done Marina. Her return to

full fitness is most welcome and helped provide the basis of a successful season culminating (so far) in a great performance at Wimbledon reaching the doubles semi final.

### Other notables this year include:

- An amazing full house on Saturday the first day of Qualies orchestrated by ASB by hosting patrons in the corporate boxes. This level of attendance resulted in the caterer's revenue exceeding the normal takings for Monday the first day of main draw.
- During the weekend patrons in large numbers watching players (especially Maria Sharapova) practising and even applauding the quality of tennis.
- Sabine Liski a 21 year old from Germany entered our tournament as a qualifier. She played 121 games plus 2 tiebreakers in five matches starting a year that has seen her go on to the heights of a Wimbledon Singles Semi Final.
- The Heritage Charity Evening with Auction and Lobbo raised \$18,000 for St John.
- Under a WTA initiative, players participated in the Tournament Aces programme mingling with sponsors, media, the public and youngsters with on-court and autograph sessions.
- We enjoyed the usual on-court activities with the players and the entertainment around the stadium.



## HEINEKEN OPEN featuring PANASONIC Singles and Doubles

As is custom two Heineken Open qualifying rounds are played at Tennis North Harbour's courts at Albany while the ASB Classic concluded. The final four matches were played at the ASB Tennis Centre as the opener for the Monday schedule.

Richard Palmer, now the dual Tournament Director for both events, maintained the strong recruitment programme established over the years with 3 players in the top 20 and a cut off for the main draw of 64. In addition two wild cards were offered to Nicholas Almagro (highest ranking 11) as second seed and Arnaud Clement (highest ranking 10) – great additions to the field.

Representatives from 23 nations competed in the Heineken Open with a large contingent of 22 players from Spain, Italy and France (the Romance language countries). We witnessed some hard fought matches – during the singles events 20 matches played out to 3 sets including 26 tie breakers. The seedings confirmed expected performances with 6 seeds playing through to the quarter finals and 3 to the semis. The exception was Santiago Giraldo a 23 year old Columbian playing well above his ranking of 64 – the cut off level.

Finals day was a great day for Spain. The ASB Tennis Centre looked great, we had a full house, the weather was fine so the scene was set for some good tennis. David Ferrer was victor over David Nalbandian 6-3 6-2 showing the crowd the level of performance of world class players (4 versus 3 at highest ranking). And in the doubles the Spanish team of Marcel Granollers/Tommy Robredo in a close match beat Johan Brunstrom (Sweden/Stephen Huss (Australia) 6-4 7-6(6).

## Notable points

As the year has unfolded it shows that:

- Many of the finalists at the Grand Slams and other major tournaments have played in the Heineken Open.
- Michael Venus the only Kiwi in the Singles Main Draw took a set off Tommy Robredo a former world No. 5.
- Kids Day now on the Monday continues to be fun and it is great to see some of the pros joining in.
- The on-court entertainment with Heineken Big Serve, Kia Car Race, Panasonic Ball Hit Out and live music were activities of interest to the crowd.
- Heineken After Party. The new elevated back courts (now 2, 3 and 4) were dressed up for party time providing the opportunity for patrons to watch the finals on the big screen in a great environment with great atmosphere. Well done Heineken for setting up this ideal location and providing the best hospitality.

## CONCLUSION

As reported earlier, the 2011 International Tournaments were played out on a construction site. The temporary facilities created a few problems but the whole team, ably led by Richard Palmer and Mellany Mann, worked together to ensure that all the behind-the-scenes activities functioned well and did not create problems around the stadium. We look forward to the completion of the project and an harmonious working relationship in the future with the Next Generation Club.

We are well supported by our team of wonderful sponsors – ASB, Heineken, KIA, Panasonic, Heritage Hotels and all the other sponsors who contribute immensely to the success of the tournament fortnight. The financial support is greatly appreciated but also the managerial expertise, the time and effort and spirit of co-operation is most welcome – thanks to you all.

We are indeed lucky to have such a wonderful team of volunteers and staff who give so willingly of their time and energy to present a first class event – thanks to every person involved over the fortnight.

Finally to the tennis family who come along to share in the fun at the ASB Tennis Centre. It would be no good if we had an empty stadium. Thanks for being part of it this year – you will be very pleased with the finished facilities next year. See you there!

# Clubs and Schools Report

## Schools Programme

The Tennis Auckland Schools programme changed direction this year, moving away from the one session introduction model, to a four week Grasshopper Programme designed to give school aged children a longer series of “taster” sessions. This resulted in wide ranging support of the Grasshopper concept and the programme has grown in strength and numbers.

Fifty five schools participated in the Grasshopper Programmes over the year as well as receiving full Grasshopper equipment kits that are kept permanently by each school. The kits included 30 rackets, 2 portable nets, 72 balls and a carry bag. The programme

involves four weeks of coaching usually conducted by the local club coach, a resource manual and a professional development session for staff.

This programme has been funded by The Four Winds Foundation, Sport Auckland, Sport Waitakere and Counties Manukau Sport and resulted in 12,500 children participating. Tennis Auckland is very appreciative of this funding support which has resulted in the programme becoming a resounding success within the Auckland community.



## Grasshopper Tournaments

Over 600 youngsters participated at 23 Grasshopper Tournaments at various Auckland clubs. The largest entry attracted 73 children to one of the events hosted by the Remuera Rackets Club making it the largest tournament of this type in New Zealand. Twelve Auckland Tennis club coaches signed up to stage these events to help encourage youngsters into the sport through fun competition.

## Open Day

The National Open Day was held in February 2011 and encouraged 103 visitors to join a Tennis Auckland affiliated club. There were approximately 900 visitors overall on the day who paid a visit to at least one of the 27 participating clubs on the day. Promotional material in the form of posters and flyers was given to each club for distribution. Editorials appeared in local suburban newspapers to promote visits to the clubs involved on the day.

Many clubs put a lot of time and effort into the distribution of the promotional material and the organisation of activities for visitors to enjoy at the club, with the overall turnout being very positive.



## Easitennis

There were 224 Easitennis participants this year, which was slightly up on the previous year. The three-week six-session courses were delivered at four venues across Auckland – Scarbro Tennis Centre, Nicholson Park, Manukau Tennis Centre and, for the first time, the Pompallier Tennis Club.

The classes after Christmas proved to be more popular than the courses in October and November. Many of the post Christmas participants took advantage of an invitation to visit clubs on Open Day and according to several sources a number of them became club members. The coaches at all of the four venues carried out the delivery of this successful adult beginner programme in a professional manner and this was greatly appreciated by Tennis Auckland.

This is a great result considering one of the most popular venues, the ASB Tennis Centre was under development during the year.

## Senior Interclub

2010/2011 was another highly successful interclub season attracting 537 team entries including the twilight and winter competitions. This is the biggest tennis competition of its type in New Zealand.

Interclub team numbers were up by 10 on the previous year to 407. Twilight entries reached 56 in total and winter attracted 74 entries equalling the same number of teams as the previous year – 537.

The weather was very kind to the competition with only a couple of rained out days during the entire season. Many thanks to Raewyn Hooper for her successful administration of the interclub competition.

It is very pleasing for me to mention that there were very few complaints throughout the season and this reflects the calibre of people involved. Thank you to the players, team captains and the interclub controllers for making this competition the best of its kind. The Senior Interclub Club of the Year for the 2010/2011 season was the Sunnyhills Tennis Club.

The Scarbro Caro Bowl season continued to be the flagship club competition for New Zealand's leading players and produced a thrilling men's final between Parnell and Campbell Park. Alistair Hunt, showing glimpses of his best tennis and plenty of character, wrapped up the match at 1am for his Parnell team.

Parnell also claimed the Scarbro Caro Bowl women's title with a polished display of team tennis against Royal Oak in the final played at the Parnell Tennis Club. Tennis Auckland acknowledges the continued support of Scarbro Construction for their sponsorship of our premier interclub competition.

A word of thanks to Greg Peters from Configure Express for a financial contribution allowing Tennis Auckland to introduce a new mechanism to help prevent undesirable on court behaviour. Thanks to Ross Morrison for volunteering to coordinate this initiative and to Brian Keane for his assistance in tidying up the procedure for any complaints.

Once again, thanks to all of the interclub controllers for their input at the end of season debriefs for both Senior Interclub and the Scarbro Caro Bowl. These forums provide us with the opportunity to review the competitions and make them even better.

## Junior Interclub

Team entry numbers were consistent with the previous year with 311 teams competing in the Pre Christmas competition and 327 teams involved after Christmas. There were relatively few withdrawals and the season ran very smoothly aided by plenty of summer sunshine.

Scheduling of matches was challenging with the redevelopment of the ASB Tennis Centre. School courts were unavailable post Christmas so, with careful scheduling of courts during the season the competition was completed on schedule.



Campbell Park won the Junior Club of the Year for the second time in a row with some impressive team results and a large number of team entries.

The Scarbro Junior Caro Bowl was won by Remuera in the boys section and Campbell Park in the girls section. Many thanks to Scarbro Construction for its support of this event.

Well done to all players, team captains, parents and interclub controllers for making this another successful season on the courts and for a continuation of competitive opportunities for our junior club members. Last, but not least, a big thank you to Dawn Morrison for her contribution ensuring the smooth running of junior interclub in the Auckland region.

## Mid Week Lead In and Summer Interclub

It was another successful year for these competitions with numbers about the same as in previous years. The Lead In competition attracted 124 entries while the Summer boasted 126 entries this season. The spirit of competition was of the highest order resulting in a season of thoroughly enjoyable tennis for all of the players involved.

The end of season debrief meeting resulted in no changes to next year's competition and Tennis Auckland is most appreciative of the input from all of the interclub controllers representing their clubs. Their efforts throughout the season ensure a successful competition and rewarding participation for many of our club members.

Congratulations to Bucklands Beach picking up the Midweek Interclub Club of the Year award in 2010/2011.

Tennis Auckland acknowledges the sponsorship by Jacobs Creek in support of this competition.

# Coaching Department Report

## Coaching Programme

Tennis Auckland has implemented a training academy for aspiring tournament players with 3 coaching tiers and approximately 70 tournament players currently enrolled. The coaching team is headed by James Greenhalgh and supported by Lee Radovanovich, Ranjit Shinde, Thiem Nguyen and Greg Owen (strength and conditioning coach).

This year the coaching programme has been designed to ensure the specific fundamentals are being taught at key times during the term in order to develop the player's skill and performance.

Fitness is a key focus of our Regional Performance Centre. Greg Owen is responsible for designing and implementing a National Fitness Test. This test, with its international benchmarks, will be used in our coaching programme to give clear goals for our players.

New Zealand's top professionals including Sasha Jones, Marina Erakovic and Daniel King-Turner spent time with our programme in preparation for their international tournaments. This experience inspired the junior players and showed them first hand the international level of play they can aspire to.

Coaching Programme partners; Tennis New Zealand, Wilson and Asics continue to help and maintain the quality of the coaching programme. The Asics shirts define which level and status players have reached in the programme and give them a visual goal to strive for.

## Tournament

Some of the highlight results worth mentioning have been: AKL ITF; Cameron Norrie was our stand out performer making the final but going down to AUS Blake Mott in three sets. Cameron has recently represented New Zealand in the Junior Davis Cup where he beat the number 1 player from Korea and pushed the number 1 ranked player from Japan before going down in three sets. Alex Klintcharov also represented New Zealand and our programme coach, Ranjit Shinde, was the team captain.

# Tennis Seniors Auckland

## **The past year has been an eventful one for Seniors Tennis both in New Zealand and in Auckland.**

Christchurch hosted the ITF World Team Championships for Seniors tennis players in February 2011. Several Auckland players were selected for New Zealand teams. This is a prestigious event with Seniors tennis players competing from around the world. Unfortunately, the earthquake disrupted the event. Christchurch was also to have hosted the National Teams Event over Easter. That event was transferred to Auckland at short notice. Tennis Seniors Auckland greatly appreciated the support of the tennis clubs in the Eastern Suburbs who were prepared to make their courts available for this tournament. That support reflects the fact that almost all of our members belong to individual tennis clubs in Auckland, with Tennis Seniors Auckland supplementing the tennis opportunities available to those players.

This relationship with Clubs through a common membership, whilst a strength for Tennis Seniors Auckland, is also its Achilles heel. Like any other amateur organisation, Tennis Seniors Auckland looks to its membership for volunteers to assist with the administration and to run social and competitive play. But many of its members are committed to assisting their own clubs. Tennis Seniors Auckland over the past few years has had only a handful of members dedicated to running the Association. It desperately needs an influx of new faces on its Board.

The National Teams Event at Easter was a great success for Tennis Seniors Auckland both from the point of view of hosting the Event at very short notice and for the results on the tennis court. The total number of teams competing was down from previous years as was to be expected, but the standard of tennis remained extremely high. Of the 10 Auckland teams that competed, 5 won their age group and 3 came second in their age group.

During the year Tennis Seniors Auckland played representative fixtures against the Hibiscus Coast, Counties, South Auckland, Lower Northland and Northland. A quadrangular tournament between Auckland, Waikato, North Harbour and Bay of Plenty was planned but for a number of reasons did not gain traction and was ultimately cancelled due to poor weather. It is noticeable that these fixtures are becoming increasingly competitive perhaps as a result of a growing interest in Seniors tennis amongst the 35 to 45 age group. The social element of these fixtures, however, remains a key feature. It is perhaps the melding of these two factors that makes these representative fixtures so popular with Seniors players at all levels.

Attracting players to our two tournaments in April and at Labour Weekend continues to be a challenge. We held the 2010 Labour Weekend tournament at the Eden Epsom Tennis Club. This proved to be a popular venue and arrangements are already in place to hold the 2011 Labour Weekend tournament at the Eden Epsom Tennis Club. We were also fortunate in receiving sponsorship from Farmers for the event. Farmers have confirmed that they will continue their support of this tournament this coming Labour Weekend. This support is greatly appreciated.

Whilst Tennis Seniors Auckland offers tennis at the highest standard and the occasional opportunities for some to play at an international level, the emphasis remains on the enjoyment of the game and the friendships that last long after the matches have been completed. Our membership remains strong and continues to encompass players from the international level to those who simply wish to avail themselves of an afternoon of organised social play with other players of their own age and ability.

The secondary school competition in 2011 involves 322 six-member teams (191 boys' teams and 131 girls' teams) from 59 schools in the greater Auckland area, with over two thousand players taking part. Unfortunately one Saturday in Term 1 was completely rained out, and the same thing happened on the reserve Saturday. However, results were complete enough to establish the top teams for the Term 4 playoffs.

There were two notable achievements at this year's ASS Champion of Champions Tennis Tournament in March. Both Chester Espie of Westlake Boys and Danielle Feneridis of Westlake Girls achieved the feat of having won all three grades at the tournament. Chester won the Junior Boys' title in 2007 and the Intermediate title in 2009. He came very close to winning the Senior title in 2010, but made no mistake this year to complete his trifecta. Danielle, having won the Junior title in 2009 at her second attempt, won the Intermediates last year, and this year upset last year's Senior winner, Mikaela Davies of Takapuna. # Notes To The Financial Statements

For the year ended 30 April 2011

## 1 STATEMENT OF ACCOUNTING POLICIES

### a. REPORTING ENTITY

Tennis Auckland Region (Incorporated) is an incorporated society registered under the Incorporated Societies Act 1908.

The financial statements of Tennis Auckland Region (Incorporated) have been prepared in accordance with generally accepted accounting principles.

The Society qualifies for differential reporting based on the following criteria:

- it is not publicly accountable and
- the Society is 'not large' as defined by the New Zealand Institute of Chartered Accountants

The Society has adopted all available reporting exemptions.

### b. MEASUREMENT BASE

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an historical cost basis are followed by the entity. Accrual accounting is used to recognise income and expenses as they occur.

### c. SPECIFIC ACCOUNTING POLICIES

The following specific accounting policies which materially affect the measurement of financial performance and the financial position have been applied:

#### i. Depreciation

Depreciation is charged on a straight line basis at rates appropriate to the estimated economic life of each category of asset.

The assets of Tennis Auckland Region (Inc.) are depreciated:

#### Fixed Assets

Fixed Assets are recorded at original cost price less accumulated depreciation. The Society has a policy of expensing items of a minor capital nature as appropriate

#### ii. Foreign Currency Transactions

Transactions in foreign currency are, unless covered by forward exchange contracts at the forward rate of the contract, translated into the reporting currency by use of the spot rate or rate approximating this rate in effect at the transaction date.

Transactions in foreign currency not settled in the accounting period resulting in monetary assets and liabilities are translated into NZD at the foreign exchange rate ruling at balance date. Foreign exchange differences arising on translation are recognised in the Statement of Financial Performance.

## iii. Goods and Services Tax

Financial information in these accounts is recorded exclusive of GST with the exception of receivables and payables which include GST. GST payable or receivable at balance date is included in the appropriate category in the Statement of Financial Position.

## iv. Accounts Receivable

Accounts Receivable are stated at expected realisable value.

## v. Income Tax

The Society has Charitable status and is therefore exempt from income tax. The Society was registered with the Charities Commission in December 2007 (CC20231).

## vi. Stock

Stocks of tennis ball inventories are recorded at original cost price.

Some of the stock may be subject to reservation as to title.

## vii. Leases

The entity leases certain land and buildings.

The operating lease payments, where the lessors effectively retain substantially all the risks and benefits of ownership of the leased property, are included in the determination of the Net Deficit for the year..

## viii. Comparative Figures

The comparative figures represent the 12 month period to 30 April 2010.

## ix. Consistency

There have been no material changes in accounting policies during the year.

## 5 FIVE YEAR SEATS

The receipts from five year Redwood and Robinson grandstand seats have been brought into revenue as to 1/5th of total receipts for the year. The balance of the account disclosed under Non Current Liabilities represents the prepaid portion to be brought to revenue over the next 2 to 4 years.

## 6 LONG TERM BORROWING

### a) ASB BANK Mortgage

This mortgage is made up of an advance of \$2,000,000 with principal of \$585,118 remaining payable.

This loan is now subject to an interest and principle repayment regime. There is a right to make lump sum payments off the loan when funds are available.

The current interest rate is 5.42 % p.a. on \$585,118.

### b) ASB BANK Mortgage

The ASB Centre redevelopment has facilitated an further advance of \$460,000, which is subject to and interest only regime.

### c) Auckland City Mortgage

The principal outstanding on this Mortgage is \$17,500

The terms of the total Mortgage advance are:

- Interest rates are reviewable periodically
- Principal repayments are \$12,500 per quarter
- Total grants from Auckland City against this mortgage amount to \$500,000.

The loan is secured by a registered mortgage over the Tennis Auckland Region (Inc.) land at Merton Road, Glen Innes.

## 7 VALUATION OF BUILDINGS AND IMPROVEMENTS

The buildings and improvements at the ASB BANK Tennis Centre, Scarbro Tennis Centre and Manukau Tennis Centre were valued by an independent registered valuer on 27 April 2009 for insurance purposes at a reinstatement cost estimate of \$22,615,000.

The buildings and Improvements were revalued in 2010 to their insured values. This revaluation is to recognise the on-going value of those assets that have been previously written down by the annual depreciation charge. Land has been revalued at its rateable value.

The ASB Tennis Centre has been excluded from this revaluation due to the redevelopment in progress. Upon completion, the ASB Centre will be revalued.

This year the insurance replacement value of the ASB Centre Dome Roof has been included as a revaluation of that asset.

These assets are owned by Tennis Auckland (Incorporated) and the Auckland Tennis Charitable Trust.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 APRIL 2011

### 1 STATEMENT OF ACCOUNTING POLICIES

These are the financial statements of Auckland Tennis Charitable Trust. Auckland Tennis Charitable Trust is a Charitable Trust established under Charitable Trusts Act 1957. The Trust is reporting pursuant to the requirements of its Trust Deed.

The financial statements have been prepared in accordance with generally accepted accounting principles.

The Trust qualifies for differential reporting based on the following criteria:

- It is not publicly accountable and
- The Trust is 'not large' as defined by the New Zealand Institute of Chartered Accountants.

The Trust has adopted all available differential reporting exemptions.

#### **Measurement System**

The measurement system adopted is that of historical cost.

#### **Particular Accounting Policies**

The following is a summary of the significant accounting policies adopted by the Trust in the preparation of these financial statements.

#### **Buildings**

Buildings are included at cost less aggregate depreciation provided at the rates shown in the Schedule of Buildings.

#### **Income Tax**

The Trust has charitable status and is therefore exempt from income tax.

#### **Investments**

Investments are stated at cost.

#### **Goods and Services Tax**

Financial information in these accounts is recorded exclusive of GST with the exception of receivables and payables, which include GST. GST payable or receivable at balance date is included in the appropriate category in the Statement of Financial Position.

#### **Leases**

The reporting entity leases certain land. Operating lease payments, where the lessors effectively retain substantially all of the risks and benefits of ownership of the leased items, are recognised in the determination of the operating surplus in equal instalments over the lease term.

#### **Changes in Accounting Policies**

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.
