Organisation and details

Tennis Auckland Region Incorporated (TA) is the largest of the New Zealand tennis regions comprising approximately 12,400 members in over 53 clubs. TA operates three tennis centres in greater Auckland and successfully runs two international tennis tournaments in January each year. TA provides a Regional Development Programme for aspiring junior players and offers both administrative and technical support to its stakeholder clubs. Tennis Auckland website includes information on all facets of its operations.

The Board Appointments Panel is looking to formally appoint two directors whose terms are concluding at the AGM. Nominations are sought for these appointed positions.

As defined in the Constitution, the BAP is required to evaluate applicants based on the following criteria:

Particular skills / competencies sought

Tennis Auckland is seeking applications from professionals with:

- Proven experience as a director, trustee and/or senior executive who have and understand highly effective governance skills;
- Knowledge of, and experience in, the sport of tennis at international, national, regional and/or local level in New Zealand;
- Occupational skills, abilities and experience;
- Knowledge of, and experience in, sport generally;
- The need for conflicts of interest to be minimised; and
- The need for a wide range of skills and experience on the Centre Board including skills in commerce, finance, marketing, law or business generally.

- The Board having reviewed the skills within the current Board and areas they are seeking specific skills sets, they have identified the following they are specifically interested in focusing on:
 - Marketing expertise
 - Commercial expertise
 - Club administration and tennis operational knowledge and experience

Tennis Auckland supports the principle of gender equality at a governance level.

Commitment required

All Board positions will be for a term of three years, unless a shorter term is determined by the Board Appointments Panel (for example, to deal with director rotations).

The successful candidate will join a capable Board, with a passion for tennis, who are collectively responsible for ensuring sound governance practices and processes in the Tennis Auckland region. Tennis Auckland Board meets a minimum of 8 times a year with most meetings taking approximately three hours. In addition to Board meetings, directors are involved in Board committees as relevant to their expertise and interests.
